

## SHOP RULES SURFINC.CO

### General Provisions

#### § 1

These regulations (hereinafter referred to as the "Regulations") specify the rules for purchasing goods in the surfinc.co online store maintained via the www.surfinc.co domain, in particular the rules for registering visitors to the www.surfinc.co website, rules for ordering, payment, delivery of goods, as well as complaint and return procedures.

#### § 2

The owner of the Online Store and seller of goods offered in it is Surf Inc sp.z o.o.with headquarters in Krakow, entered into the register of entrepreneurs under the number KRS 728287, NIP number: 9592006709, REGON 380017233. Company address: Surf Inc Sp. z o.o.

The Store's warehouse is located in Szczecin (70-606) at ul.Hryniewieckiego 1 Mag.3 p.2

#### § 3

Whenever the following terms are used in these Regulations, they should be understood as:

Customer - a person who is at least 18 years old, with full legal capacity or a legal person or an organizational unit without legal personality, whose legal provisions confer legal capacity, which made purchase, or registered in the surfinc.co Store Civil Code - the Act of 23 April 1964 Civil Code (Journal of Laws 1964, No. 16, item 93, as amended); Account - an individual profile assigned to the Customer after registering in the Store; Login - individual and unique name of the Customer, being the Customer's e-mail address, provided by him during the Account registration process; Seller - Surf Inc Sp. z o.o. with its registered office in Kraków, entered into the Register of Entrepreneurs of the National Court Register under KRS number 728287, NIP number: 9592006709. Store - an online store run by the Seller, operating at www.surfinc.co Website - website www.surfinc.co Goods - a product offered to the Customer by the Seller via the surfinc.co Store Act - Act of 30 May 2014 on consumer rights (Journal of Laws 2017.683 i.e. from 2017.03.30); Act on the protection of personal data - the Act of 29 August 1997 on the protection of personal data (Journal of Laws 2016.922, i.e. from 2016.06.28). Order - Customer's declaration of will, specifying the goods presented in the Store and its quantity, constituting the Customer's submission of an offer to the Seller to conclude a distance sales contract through the Store of goods being the subject of the order;

#### § 4

By registering an Account and purchasing goods in the Store, you accept the Regulations. Account registration is only possible after accepting the Regulation. By selecting the "I accept the Regulations" option in the registration window, the Customer confirms that he has read the Regulations and accepts it.

#### § 5

The seller conducts mail-order sales of goods through the store in the Republic of Poland and abroad.

#### § 6

The store does not direct its activities outside the territory of the Republic of Poland, but only allows customers to indicate as a place of delivery a country other than the Republic of Poland, on the principles set out in these Regulations.

§ 7

These Regulations apply only to purchases made in the Store only by persons who are Customers within the meaning of these Regulations.

§ 8

In the event of a change in the Regulations, the Customer will be informed about it by means of a message sent to the e-mail address provided by him. The current Regulations are always available on the surfinc.co Store's website. Customer Account

§ 9

Purchases in the Store are made on the basis of a correctly completed and successively sent order form to the Seller, available on the surfinc.co Store's website

§ 10

In order to make a purchase in the Store, one-time creation of an individual Account is required during the registration process on the Store's website or purchase bypassing the registration process.

§ 11

During the Account registration process, the user is required to complete the registration form placed on the Store's website, in which the user provides his e-mail address, which is the Login, an individual password for the Account set by the customer and indicates: name, surname, contact telephone number and current address .

§ 12

After the Account is correctly registered, the Customer gains the ability to access the Account and purchase goods presented on the Store's website.

§ 13

The account password entered by the Customer into the registration form is not disclosed to the Seller.

§ 14

Prices of goods available in the Store are given in Polish zlotys, euros, US dollars, British pounds and include VAT.

§ 15

All goods presented in the Store are brand new, original, free from physical and legal defects and legally marketed in the Republic of Poland.

The goods presented on the Store's website do not constitute the Seller's offer in
