

APPENDIX NO. 1

RULES FOR REDEEMING GIFT VOUCHERS PROVIDED AS PART OF THE WOŚP CHARITY AUCTION

§1. General provisions

This Appendix sets out the special rules for redeeming gift vouchers (hereinafter referred to as the “Voucher”) provided as part of a charity auction for the benefit of the Great Orchestra of Christmas Charity (WOŚP), organized through WOŚP’s official channels.

In matters not regulated by this Appendix, the provisions of the Surf Inc. Gift Voucher Terms and Conditions shall apply.

A Voucher provided as part of a WOŚP auction is of a charitable nature and does not constitute a standard commercial offer of the Seller.

§2. Nature of the Voucher

Funds obtained from the WOŚP auction constitute a donation to the Great Orchestra of Christmas Charity and do not constitute payment for the Voucher within the meaning of applicable law.

The Voucher is intended solely for use by the person who won the WOŚP auction.

§3. Prohibition of resale and transfer of rights

A Voucher provided as part of a WOŚP auction may not be resold, transferred for consideration, or used for commercial purposes.

Transfer of rights to the Voucher to third parties without the prior written consent of the Seller is prohibited.

The Seller reserves the right to refuse to redeem the Voucher in the event of a breach of this section.

§4. Scope and conditions of redemption

The Voucher may be redeemed only within the scope and under the conditions specified in the WOŚP auction description.

The Voucher may not be combined with other promotions, discounts, discount codes, or special offers.

The Voucher is not redeemable for cash, in whole or in part.

The Voucher is single-use and may be used in only one transaction.

§5. Validity period

A Voucher provided as part of a WOŚP auction is valid for the period indicated in the auction description, but no longer than 12 months from the auction end date.

After the expiry date, the Voucher expires and any unused rights are forfeited and non-refundable.

§6. No right of return or withdrawal

A Voucher provided as part of a WOŚP charity auction is not subject to return, exchange, or withdrawal from the agreement.

Funds transferred as part of the WOŚP auction are non-refundable in all cases.

§7. Liability

The organizer of the charity auction, the Great Orchestra of Christmas Charity, bears no responsibility for the redemption of the Voucher.

Responsibility for proper redemption of the Voucher rests solely with the Seller.

The Seller shall not be liable for failure or delay in redeeming the Voucher due to reasons beyond its control.

§8. Final provisions

Participation in the WOŚP auction constitutes acceptance of this Appendix and the Surf Inc. Gift Voucher Terms and Conditions.

In the event of discrepancies between the Gift Voucher Terms and Conditions and this Appendix, the provisions of this Appendix shall prevail.

This Appendix enters into force on the date of publication and applies to all Vouchers provided as part of the WOŚP auction.
